CLINICAL HISTORY

History:

Child was apparently alright 8 days back when she developed of fever, undocumented, not associated with chills and rigor, no diurnal variation, decreased with medication. She also developed pain abdomen 6 days back, which was dull, diffuse, non radiating, periumbilical, moderate grade not increased with any factor. She also developed of loose stool 3 days back which was watery, foul smelling, yellow, bleeding after stopping of loose stools (not passing proper stools 5 days on and off with passage of flatus, intake of Ayurvedic medication, Inj. Meropen X 3 days, 1 unit FFP given. There was history of constipation 6 months and pain in passage of stools, some treatment 5 months. Child was admitted in Astha hospital 3 days. With above mentioned she was admitted in SGRH for further evaluation and treatment.

PHYSICAL EXAMINATION

Pulse: 140/min. BP: 92/62 mmHg Temperature: 37.9 degree C Weight: 15 Kg. Height: 97 cm.

General Examination:

Child was conscious, oriented, afebrile.

No pallor, icterus, clubbing, cyanosis, lymphadenopathy or oedema.

Systemic examination:

RS - Chest clear bilaterally. Air entry equal. No crepitations or wheeze.

CVS - Heart sounds normal. No murmur heard.

P/A - Abdomen is soft, not tender and not distended. No hepatosplenomegaly. Bowel sounds are normal.

CNS - Child was conscious and oriented. Muscle tone and reflexes are normal. Plantars are down-going. No signs of meningeal irritation. Pupils are normal sized and normally reactive to light bilaterally

CLINICAL SUMMARY

Child was admitted with above mentioned complaints in PICU. After sending relevant investigations child was started on IV antibiotics along with other supportive treatment. Initial investigations revealed Hb-7.4, TLC-6.06, Platelet-98, PT/INR-12.6, APTT-71.9, LFT- Normal, RFT- (BUN-4.85, Creat- 0.41, Calcium- 7.44, Na-138, K-4.79, Bicarbonate-18), Lipase- 332.80, Amylase-59, S.Procal-1.64, Dengue NSI Ag VIDAS- Negative, CRP- Positive (20), Leptospira IgM- Negative, Dengue antibody serology (IgM)- Positive. Child was hemodynamically stable and didnot require any iotrpic or respiratory support. Child had anemia with thrombocytopenia with dengue Nsl Ag positive. 2 unit PRBC was transfused. Platelets improved gradually. Pediatric gastro and pediatric surger opinion were taken and advice followed. USG W/A done showed evidence of diffuse symmetrical circumferential wall thickening of the large bowel loops predominantly transverse colon, descending colon, sigmoid colon and rectum (maximum wall thickness is 5mm). There is associated exaggerated mural blood flow on color doppler - findings suggest possibility of colitis. CECT Abdomen done showed evidence of diffuse thickening involving portion of the transverse, descending & sigmoid colon which in the given clinical context possibly represents an infective colitis. Stool biofire sent showed vibrio cholera with cryptosporidium for whcih Nitazoxamide was started. Child remained hemodyanmicallystable with improving CBC was shifted to wards. Currently child is afebrile, alert, accepting orally well, no abdominal distension, no vomiting, passing urine and stool, urine output adequate. Child is being discharged in hemodynamically stable condition with advice to follow up.
